(The Parco Business has changed net sales under Japanese GAAP to be calculated on a net basis from FY2017.)

4. Beginning in March 2018, the tenants around the Daimaru Kobe store in the Department Store Business have been operated under lease and their sales have been transferred to the Real Estate Business.

As, beginning in March 2018, the tenants around the Daimaru Kobe store have been operated under lease and their sales have been transferred to the Real Estate Business, sales of the Kobe store are presented as "actual YoY percentage changes excluding year-ago sales of the tenants that have changed to be operated under lease." For reference, compared to year-ago sales including the portion transferred to the Real Estate Business, sales of the Daimaru Kobe store were down 6.8% YoY in November and down 4.3% YoY in total for September to November.

2. The comparison of total sales was made on a like-for-like basis excluding year-ago sales of the portion of the tenants around the Daimaru Kobe store transferred to the Real Estate Business.

Compared to year-ago sales including the portion of the tenants around the Daimaru Kobe store transferred to the Real Estate Business, total sales of Daimaru Matsuzakaya Department Stores and the Department Store Business were up 0.9% and up 1.0% YoY, respectively, in November and up 0.6% and up 0.7% YoY, respectively, in total for September to November.
